project over the years. After nearly two decades of planning, design, consultation, outreach, and construction, we have finally secured a new long-term, sustainable water supply for our customers. # **CAUSE FOR CELEBRATION**

Earlier this year, we celebrated the completion of the Yadkin Regional Water Supply Project with a pair of celebratory events.

On August 24, 2023, we held a ribbon-cutting ceremony at the Project's Water Intake Facility and Pump Station on the shore of Lake Tillery in Norwood. The ceremony was attended by elected officials and staff from Union County, the Town of Norwood, Stanly County and others and marked the culmination of almost two decades of dedicated regional cooperation and hard work.

Just a few weeks later on September 21, we held a celebration event to officially open the doors to the new Yadkin River Water Treatment Plant. Melissa Merrell, Vice Chair of the Union County Board of Commissioners, welcomed elected officials, guests, and staff from both Union County and the Town of Norwood as guest speakers reflected on water resiliency, regional partnership and the modern design of our new water treatment plant.








#### WHAT WE BUILT

Spanning more than 40 miles, the ambitious project draws water from Lake Tillery via a new intake facility and pump station in Norwood. The raw water is then pumped 30 miles to the new Yadkin River Water Treatment Plant, where it is treated and then sent via the drinking water pipeline to Union County Water's distribution system.



#### **BRIDGING GAPS, INSPIRING ENGAGEMENT: OUR COMMUNICATIONS TEAM**

Even in its earliest days, we understood the importance of establishing a thorough communications program on the Project. Our Communications team met regularly to identify project milestones and proactively address potential concerns from residents in both Union and Stanly counties, particularly those whose properties would be impacted by the pipelines. We set up a project hotline and email address to ensure residents had a direct channel to ask questions, and we developed a project website, social media posts, explanatory videos and newsletters like this one to provide accurate, up-to-date information about the project.
